



**RELEASE, WAIVER, INDEMNIFICATION
HOLD HARMLESS AND ASSUMPTION
OF THE RISK AGREEMENT**

WHEREAS in return for instruction in firearms use of premises and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Undersigned agrees to the following:

The Undersigned agrees to indemnify, hold harmless and defend Governors Gun Club LLC (GGC), and any of its employees, directors, officers or agents (hereinafter "Shooters"), from any and all fault, liabilities, costs, expenses, claims, demands or lawsuits arising out of, related to or connected with: the discharge of firearms: the course of instruction: GGC range, building, land and premises (hereinafter "Premises"); and, the Undersigned's presence and or use of said Premises. And should any such claim, demand or lawsuit arise or be asserted in any way whatsoever related thereto, whether arising under the laws of the United States, Georgia, or under any theory of law or equity, the Undersigned will indemnify, hold harmless and defend GGC, from any and all costs, expenses or liability including, but not limited to, the cost of any settlement or judgment made or rendered against GGC, whether individually, jointly, or solid with the Undersigned, together with all costs of court and other costs or expenses incurred in connection with any such claim, demand or lawsuit, including attorney's fees.

The Undersigned furthermore waives for himself/herself and his/her executors, administrators, assignees or heirs any and all rights and claims for damages, losses, demands and any other actions whatsoever, which he/she may have or which may arise against GGC, (including but not limited to any and all injuries, damages or illnesses suffered by the Undersigned or the Undersigned's property), which may, in any way whatsoever, arise out of, be related to or be connected with: the course of instruction: the Premises, including any latent defect in the Premises; the Undersigned's property (whether or not entrusted to GGC: and, the discharge of firearms. GGC shall not be liable of, and the Undersigned, on behalf of himself/herself and his/her executors, administrators, assignees or heirs, hereby expressly releases GGC from any and all such claims.

The Undersigned hereby agrees to indemnify and save and hold harmless the **releases** and each of them, from any loss, liability, damage or costs they may incur due to my participation in the GUN RANGE, whether caused by the negligence of any or all of the **releases**, or otherwise.

The Undersigned hereby expressly assumes the risk of entering the Premises and of taking part in activities on the Premises which include, but not limited to, the discharged of firearms and the firing of live ammunition.

The Undersigned furthermore hereby acknowledges and agrees what he/she has read, understands and will at all times abide by GGC rules and procedures.

This instruments binds the Undersigned and his/her executors, administrators, assignees or heirs.

SAFETY RULES

1. User of the range must be familiar with any firearm used on the shooting range and must handle all firearms in a safe reasonable manner.
2. Firearms brought into the range shall be cased or holstered until forward of the yellow ready line (painted on the floor behind the assigned shooting stall).
3. Loading and unloading of firearms on the range is permitted only when the firearm is pointed downrange, in front of the ready line, at assigned shooting stall.

4. Only authorized firearms and ammunition may be used. Steel core, steel jacketed, tracer and incendiary rounds are prohibited. Only cartridges with a maximum velocity of 3400 FPS or less may be utilized.
5. Use of eye and ear protection mandatory on the range at all times.
6. When leaving the firing line, firearms must be cased or holstered.
7. Should a misfire or other malfunction occur, keep the firearm pointed downrange. Place the firearm on shelf, pointed downrange and obtain assistance. Do not leave the firing line with a loaded or jammed firearm.
8. **ONLY SHOOT AT YOUR TARGET. NO CROSS LANE SHOOTING!**
9. **BE SURE OF YOUR TARGET.** Firing at ANYTHING other than approved target will result in revocation of range privileges and being held liable for damage.
10. Accidental discharges, damages or injuries must be reported to the staff member immediately.
11. **NEVER** move forward of the firing line.
12. **NO DRAWING FROM HOLSTER.**
13. **NO RAPID FIRE.**
14. Use of the range while under the influence of alcohol or drugs is strictly prohibited.
15. Smoking, eating or drinking are prohibited on the range.
16. Directions given by staff members shall be followed at all times.
17. Wash your hands after shooting.
